- 1) The State Government reserves the right to withdraw the above Certificate at any time if the Management fails to comply with the instructions of the State Government such as illegal removal of the teachers, non-payment of salaries to the teaching and non-teaching staff as per the approved scales etc.
- 2) Admissions should be made with the bonafied date of birth certificate.
- 3) All the un-trained teachers should be replaced by the trained teachers.
- 4) The Management should collect the tuition fee and Special fee etc., as prescribed by Government from time to time.
- 5) The strength in classes should be as per rules in force.
- 6) The Management should follow the State syllabus for Classes from I to V.
- 7) The School should follow the three Language formula.
- 8) The D.E.O., or his nominee should be invited when the Management makes recruitment of candidates for various categories of posts.

- 14) No classes should be opened without prior sanction/permission from the Competent authority.
